NOTIFICATION: EUR-EuroSTR-COMPOUND to be added to the DSB Reference Rates list

Audience: All DSB users

SUMMARY

The DSB will shortly be introducing changes to accommodate a new reference rate, EUR-EuroSTR-Compound to dovetail with updates to be made to the coding schema in FpML. Further information on the change and the DSB's implementation plan can be found below. The changes reflect the [ECB's expected publication of new Euro short term rate \(€STR\)](#) from 2nd October 2019

BACKGROUND

The ECB's Governing Council has decided to develop a euro short-term rate (€STR) based on data collected by the Eurosystem for money market statistical purposes. The €STR will reflect the wholesale euro unsecured overnight borrowing costs of euro area banks and will complement existing benchmark rates produced by the private sector, serving as a backstop reference rate.

The DSB will therefore add "EUR-EuroSTR-COMPOUND" to the list of available

reference rates for OTC Rates and Cross-Asset (“Other”) instruments that include a IR Reference Rate as an underlying asset.
