Dear Users,

On Friday 10th April the DSB entered a Heightened Awareness Period and put in place additional governance and controls regarding all change to DSB systems. This notification provides an update on the DSB's new Rates Options template release which was postponed in March 2020 due to the DSB's change freeze which was in place at that time. This release has successfully completed the review process and has been rescheduled as detailed below.

This release introduces a new template, the adoption of which is optional so users are not required to introduce any new functionality or amend their existing processes at this time. Those users wishing to adopt the new template can do so in accordance with their own timelines.
