Notification : DSB Release : June 2020 - update

Audience: All DSB Users

Summary:

This notification is to inform all DSB users of an update to the June 2020 release.

In addition to the USD reference rates the DSB will be adding a Turkish Reference Rate and three Credit Indices to the enumeration lists.

The DSB will therefore be adding the following new Reference Rates to the available set of underliers for relevant Rates products:

- USD Swap Rate-BCMP1
- USD Treasury Rate-BCMP1
- TRY-TLREF-OIS-COMPOUND

The DSB will be adding the following Credit Indices to the available set of underliers for relevant Credit Index products:

- CDX.NA.IG.BBB
- CDX.NA.HY.Ex-BB
- iTraxx MSCI ESG Screened Europe Index

Only users seeking to use the new reference rates or credit indices will need to update their systems and processes.
