**NOTIFICATION: DSB UAT – Industry-wide Load Testing**

**Audience:** All DSB UAT Users

Whilst the DSB UAT environment is in a failover state (as part of the planned UAT disaster recovery test), the DSB would like to take this opportunity to invite DSB UAT users to undertake a load test of the UAT environment.

**Notification details:**

- An industry-wide load testing event will to be scheduled between September 1st 2021 - 00:00 UTC and September 2nd 08:00 AM UTC
- During this window, the main purpose of the UAT environment will be for load testing. Users performing standard UAT functionality testing should be aware that UAT system performance and availability is likely to be materially different from other uptime periods.
