was based on feedback from a DSB user that they were unable to accurately assess the impact of the release from the technical specifications, published on 20th July, until the publication of the JSON templates at the start of UAT on 24th September. The user felt there was insufficient time to undertake the changes.

Whilst almost all users of the DSB were ready for the release, the DSB is mindful that the impact of a delay in this specific case is minor: the delay will not impact the UPI implementation timelines nor any other regulatory or industry milestones.

The user feedback has highlighted a potential improvement to the DSB's notification protocol in order to provide additional transparency about non-backwardly compatible changes. The DSB will discuss with the TAC whether for future releases that are non-backwardly compatible, the DSB should publish the JSON templates earlier than at the start of UAT.
