The DSB will be hosting a second webinar on the EU draft rules to modify the ISIN covering implementation considerations such as product changes, milestones and governance. Following a presentation from the DSB, a Q&A will take place to allow industry to further their understanding of the proposal.

Context:

On 12 June 2024 the European Commission (EC) published its draft [Delegated Act^{\[1\]}](https://ec.europa.eu/info/law/better-regulation/have-your-say/initiatives/14017-OTC-derivatives-unique-identifier-for-public-transparency_en) on OTC derivatives identifying reference data for transparency, open for consultation until 10 July.

With the EC's delegated act proposing modification to the OTC derivative ISIN's reference data, the DSB is keen to ensure stakeholders are involved in this process.
