The Derivatives Service Bureau (DSB) annual industry consultation is now open. This year the consultation focuses on ensuring that the core principles of fair allocation of

costs and data access are incorporated throughout the UPI and OTC ISIN Services.

The topics on which the DSB is seeking stakeholder views are:

- Fair Allocation of Cost Recovery
- Extension of Intermediary Model to All User Types
- Cost Allocation Policy between UPI and OTC ISIN Services
- Acceptable Usage Policy breaches

The diversity of the DSB's userbase means that feedback from the various jurisdictions, organisation types and sizes is key. All stakeholders are encouraged to respond to the consultation, or parts thereof, to enable consideration on how to take these proposals forward.
