Background	<p>In the current OTC ISIN product definition, only syntactic validation is applied to the Underlying Instrument ISIN attribute.</p> <p>In order to maintain UPI/ISIN hierarchy, the UPI product validations will be aligned to its equivalent ISIN product. Terms of Reference	Scope	<ul style="list-style-type: none"> This CRF covers the input (Request) template of the ISIN product. 	
Requirements	<ul style="list-style-type: none"> At the moment, only syntactic validation is performed on the Underlying Instrument ISIN field. To maintain the UPI/ISIN hierarchy, there is a requirement to align the UPI product validations to its equivalent OTC ISIN product i.e., Underlying Instrument ISIN. The input Underlying Instrument ISIN must have a prefix "EZ" with its structure based on ISO 6166. The input Underlying Instrument ISIN must be a valid and existing ISIN in RDL. The input Underlying Instrument ISIN must be a valid Commodities Swap product with status not "Deleted". 		
Validation	<p>1. Underlying Instrument ISIN</p> <p>a. The following validation will be applied to the Underlying Instrument ISIN and must be a valid ISIN RDL record.</p> <ul style="list-style-type: none"> ISIN 12 characters (Prefix "EZ", 9 Alphanumeric, 1 Numeric check character) ISIN structure based on ISO 6166 ISIN <p>b. If input ISIN has more than 12 characters or does not have prefix "EZ", an error message will apply before it proceeds to create: "Value must match the pattern <code>^[EZ]{2}[A-Z0-9]{9}[0-9]\$</code>"</p> <p>2. Underlying Instrument ISIN in the record</p> <p>a. If input ISIN does not exist, an error message will apply: "Error: ISIN/s not found".</p> <p>3. Input Underlying Instrument ISIN</p> <p>a. Backward Compatibility	<p>At present, only syntactic validation is applied to the input Underlying Instrument ISIN. Once the validation is implemented, additional conditions will be included in the existing validation for the attribute.</p> <p>The existing invalid OTC ISINs will remain in the DSB RDL but will be subject to the following functional restrictions:</p> <ul style="list-style-type: none"> • Unable to create invalid ISINs by attribute • Unable to retrieve by attribute • Able to retrieve by ISIN • Able to search by supported attribute <p>All functionalities are available for existing valid OTC ISINs.</p> <p>Details of these functions are provided below:</p> <ul style="list-style-type: none"> • Retrieve or Create ISIN Record - Users submit request attributes to the system and DSB returns the recorded version of the ISIN or generate a new ISIN if not yet created in the system. <ul style="list-style-type: none"> a. User will enter the request attributes, then the system validates the input data including the new validations for the Underlying Instrument ISIN. b. If the request attribute is valid, the DSB will return a recorded version of an ISIN or generate a new ISIN if not existing. c. If the request attribute is invalid, the DSB will return an error message and will not retrieve or create an ISIN record. d. The DSB will not inform users whether an ISIN exists in the DSB record or not. • Retrieve No Create - Users can retrieve an ISIN, and attributes related to that ISIN (including the derived attributes) if it already exists. This does not create a record if no ISIN is found. <ul style="list-style-type: none"> a. User will enter the request attributes, then the system validates the input data including the new validations for the Underlying Instrument ISIN. b. If the request attribute is valid, the DSB will return a record template (attributes and derived) but will not generate an ISIN or will provide an ISIN record template if existing. c. If the request attribute is invalid, the DSB will return an error message and will not retrieve an ISIN record. d. If ISIN has not been created in the DSB yet, the system will provide an error message and will not generate an ISIN. • Retrieve ISIN Record by ISIN - Users utilize the search function by providing the OTC ISIN, and the DSB returns the record attributes. <ul style="list-style-type: none"> a. If the user provides the OTC ISIN, the system will return the record template based on the appropriate version of the record template. • Search for ISIN Record - User can search for an existing OTC ISIN based on a number of criteria (i.e., ISIN attributes). <ul style="list-style-type: none"> a. User needs to use the Lucene search string to search for an ISIN record.
