Impact Details

This is a new OTC ISIN Product Definition template where attributes, values and codes are based on <u>ISO 10962</u> Classification of financial instruments (CFI code) - Third edition 2015-07-15.

The new OTC ISIN Product Definition template will support all Categories [Instrument Types] and Groups (Asset Classes) and will derive the following values based on the attributes selected.

a. Derivation of CFI Codes – <u>See OTC ISIN Product Definition Document Section 4.2.1</u>

User is able to select only one Category [Instrument Type] and Group [Asset Class]. Once Category and Group is selected, the user must select the CFI attributes and values where applicable. Once selected, the returned UPI Record must contain the complete CFI Codes with details provided in Appendix 2.

b. Derivation of Full Name - See OTC ISIN Product Definition Document Section 4.2.2

The derived value of Full Name is based on the input CFI attributes where applicable long name is provided in Appendix 2.

c. Derivation of Short Name (FISN) - See OTC ISIN Product Definition Document Section 4.2.3

The derived value of Short Name (FISN) is based on the input CFI attributes where applicable abbreviation is provided in Appendix 2.

- d. Derivation of Commodity Derivative Indicator <u>See OTC ISIN Product Definition Document Section 4.2.4</u> The derived value of Commodity Derivative Indicator is based on the input Category and Group provided in Section 4.2.4.
- e. Derivation of Issuer or Operator of the Trading Venue Identifier <u>See OTC ISIN Product Definition Document</u>
 <u>Section 4.2.5</u>

The derived value of Issuer or Operator of the Trading Venue Identifier is fixed at "NA".

Backward Compatibility

This is a new OTC ISIN product definition template where UPI record does not exist. Therefore, backward compatibility is not applicable.
