Title	UPI/OTC ISIN: Mark Option Type/Exercise Style as Optional attributes in Multi-Exotic and Non-Standard Options templates		
Background	<p>At present, Option Type and Exercise Style are mandatory attributes in the UPI definitions whereas in the OTC ISIN definitions, these attributes are optional. Due to misalignment, the request of creating an OTC ISIN is rejected. The creation of an OTC ISIN would be subject to UPI validation.</p> <p>In order to maintain a strict hierarchy within the UPI/OTC ISIN, there is a requirement to:</p> <ul style="list-style-type: none"> Align the OTC ISIN and UPI templates for Multi-Exotic and Non-Standard Options to ensure that a parent UPI is added to the OTC ISIN record. Align the OTC ISIN templates for Commodities & Multi-Asset Non-Standard Options with Multi-Exotic (Commodities) and Non-Standard Options (Credit, Equity, Foreign Exchange, Rates). <p>As agreed by the Product Committee, the DSB is required to update the UPI definitions templates to make the entry of Option Type and Exercise Style "Optional" for Multi-Exotic and Non-Standard Options so UPI can be made available through OTC ISIN creation.</p> <p>As a result of this, there is a requirement to migrate the deprecation that has occurred in the pre-population batch process for OTC ISIN.</p>	DSB-ID	DSB-3488

For OTC ISINs created with status "Deprecated" without the parent UPI, these are to be migrated once this change is implemented.
