 Members discussed a possible approach to address the Tradeable on Trading Venu (ToTV) challenge by enriching the ISIN data from ESMA FIRDS's database 		

	 Member requested a view from the ESMA Observer on the timelines for publication of ESMA's ToTV approach. ESMA Observer stated that ESMA's ToTV approach is being drafted and ESMA are now following their standard process before publication Product Committee requested a cost estimate for implementing the proposed ToTV function in the DSB Action: DSB Secretariat to request quote from the DSB technical team
	 Product Committee agreed that the ToTV functionality could be included in the next Consultation Paper (2) for wider industry feedback, but should not be on the critical path for the release date

	 ESMA Observer reiterated that the MiFID II RTSs are now law and the only acceptable underliers under the current regulation are: ISIN, LEI and Index Name. Ir addition, the lack of an appropriate identifier for the underlier need not prevent trading but it will mean that a trading venue's reference data report will not meet the data quality assessment and may trigger discussion with the venue from the
