1 Open Actions

- Action 86: PC agreed that the exotic templates are still being developed and require further analysis before they are ready for discussion
- Action 89: PC agreed to schedule ISIN status discussion for a later PC meeting
- Action 95: To be discussed in today's meeting
- Action 102: Awaiting feedback from ESMA
- Action 106: Market vendors have decided to provide their own services to the industry. The DSB PC agreed to reconsider how to improve the quality of the data Close
 - o Action: Re-examine the data quality of credit underliers

2 Proposal to create a Commodities Taskforce

- PC agreed to establish a commodities taskforce
- to focus on any remaining challenges with the provisional product definitions
 - Action: Secretariat to build a taskforce membership list and distribute to the PC and schedule first meeting

3 FX Swap Definition

- ESMA have confirmed that FX Swaps should be treated as a single instrument rather than a package
- Members expressed concern that the wider industry were not aware of this position

 Action: Secretariat to ask ESMA if they are planning to clarify this position to the industry

4 MAC Swap Product Definition

- The DSB has agreed to issue ISINs for MAC swaps in the long term
- Member raised the challenge regarding the current MAC definition versus those IRS defined by the PC
 - Action: Secretariat to obtain full definition of the MAC swap from the current ISIN issuer

5 Portfolio Swap Product Definition

- ESMA have confirmed the portfolio swaps should be treated as a single instrument rather than a package
- Members discussed the challenges that this approach will generate and requested further clarity and also publicity by the regulator
 - Action: Secretariat to obtain further clarity from ESMA on portfolio swap approach

7 FX Option - Challenge

- Secretariat raised a challenge raised by the industry on the current FX option template that can create two ISINs for the same instrument and both those ISINs would have different CFI Codes
- Members discussed the proposed solution and agreed for the secretariat to continue to work with PC members offline to resolve
 - o Action: Secretariat to continue developing a solution for FX options

8 Challenge to Fixed Rate/Strike Price removal

- Secretariat presented the text of a question from an anonymous industry participant questioning the removal of strike price and fixed rate from the definitions
- PC agreed unanimously to maintain the current position of excluding them

9 Correlation of Strike Price & Price Field (#33)

- PC agreed that if the premium can be entered in RTS22/Field39 then the strike could be entered in RTS22/Field 33. However, this would require a change of guidance for RTS 22
 - Action: Secretariat to send the proposed approach to ESMA

10 **DSB ISO/FpML Taskforce: Update**

Secretariat briefed the committee on the status of the taskforce

11 **AOB**

- PC discussed the July UAT release product definition using ISINs to identify indices for equity index derivatives. Further discussion and evidence gathering required
 - o Action: Secretariat and PC Members to discuss further
