1. General Updates

- References to the "DSB Access and Usage Agreement" have been updated to "DSB Agreement", in line with the replacement of the DSB Access and Usage Agreement with the Main Terms and Subscription Form model.
- Minor editorial changes to improve structure, flow and clarity.
- Versioning and effective date updates (header and footer).

2. DSB Enterprise User Addendum to the DSB User Agreement

- Title of document changed from "DSB ENTERPRISE USER ADDENDUM TO THE DSB ACCESS AND USAGE AGREEMENT" to "DSB ENTERPRISE USER ADDENDUM TO THE DSB AGREEMENT" given the replacement of the DSB Access and Usage Agreement with the Main Terms and Subscription Form model.
- Section "Parties" Updated registered office address for DSB.
- "Parties" section Updated the DSB registered office address.
- 1.2 The term "Main Terms" has been capitalised as it is a defined term.
- 1.3 Updated language to "Agreement as a Power User" for improved clarity.
- 1.3 Changed paragraph reference of "DSB User Policy" to reflect changes made to the referenced document as part of the drafting of the 2023 DSB Main Terms and Policies.
- 1.4 Addition of a reference to paragraph 5.1 to ensure clarity on the applicable termination clauses.
- 2.1 Changed paragraph reference of DSB Acceptable Use policy to reflect changes made to the referenced document as part of the drafting of the 2023 DSB Main Terms and Policies.
- 4.1 Changed paragraph reference of DSB Acceptable Use Policy to reflect changes made to the referenced document as part of the drafting of the 2023 DSB Main Terms and Policies.

- 5.1 The term "Main Terms" has been capitalised as it is a defined term (in the "Main Terms" document.
- 5.1 Added term "terminate the environment and support subscription options in" to indicate that users can cancel options of the Enterprise services separately.
- 5.2 New clause to provide information on the inflation index to be used going forward for the calculation of annual fee increase.
- 5.3 New clause to update inform users that the new Enterprise fees will be published on the DSB website to improve efficiency of fee updates (as opposed to needing to update the Addendum.
- 5.5 Replaced the term "fees" with "environment and support options" for better clarity.

5.5 - Removal of columns "charges" and "total" as information is being made available on the DSB website as opposed to in the Addendum.



3. DSB Enterprise 3YR term User Addendum to the DSB User Agreement

- Section "Parties" Updated the DSB registered office address.
- 1.3 Update of reference to paragraph 2.1 to provide clarity on the termination clauses.
- 2.1 The term "Main Terms" replaces the "DSB Access and Usage Agreement" given its discontinuation from 1st January 2023.
- 2.1 To minimise yearly changes to the Addendum, the reference to a specific year when outlining renewal terms has been removed in favour of a generic reference to "each calendar year".
- Section 3 Renumbering of clauses to reflect additions made, as listed below in the Section 3 clauses.
- 3.1 Replaced the term "fees" with "environment and support options" for improved clarity.
- 3.1 Additional language included to explain that the connectivity and support options from "DSB Enterprise User Addendum" also apply to this Addendum.
- 3.1 Addition of a reference to paragraph 5.3 of the "DSB Enterprise User Addendum" for a link to the fees on the DSB website, instead of listing options in the Addendum.
- 3.2 Replaced the term "1 Year Enterprise contract" with "DSB Enterprise User Addendum" to reflect title change to the referenced document.
- 3.3 Original clause 3.3 deleted. Removal of references to discounts as the new 3-year contract options does not provide any discounts. As per the wording of 3.2, the Year 1 fees are fixed for the Addendum term.
- 3.4 Further removal of the term "discounts" given the fee level changes for the 3 year Addendum term.
- 3.4 Removal of reference to original clause 3.3 which has been deleted.
- 5.1 Updated language to "Agreement as a Power User" for improved clarity.
