	The PC REJECTED the proposal to add "OTHR" to all commodity classification branches (Base Product / Sub-Product / Additional Sub-Product. The dataset used for Base Product / Sub-Product / Additional Sub-Product is based on ISO 20022, and therefore the PC suggested that if "OTHR" is required the dataset should be updated.			
	The PC REJECTED the proposal to add "Other" to the list of Notional Schedule entries for Rates products. An existing value (CUSTOM) satisfies the request.
