UPI UAT Update

The DSB presented the PC an update on the UPI UAT progress.

Additional Products – 'Catch All' Template

The DSB presented an outline of the proposed Catch All template structure for review by the members of the PC. This included the following design principles:

- Deployment as part of the OTC ISIN and UPI services conforming to the DSB hierarchy.
- A single template for this function rather than separate templates for each asset class or instrument type.
- The direct entry of CFI attributes in valid (six character) combinations only including MMSXXX.
- Support for the entry of CFI attribute names rather than letters.
- Derivation of a complete CFI code and FISN.
- No support for the use of "X" as a substitute CFI value unless that letter is specified in ISO 10962 (CFI).
- The OTC ISIN version of the proposed template will have the same functionality but will, in addition, support the input of an Expiry Date
- The catch all template is only to be used as a template of last resort when there are no applicable standard or non standard templates.

Members of the PC reviewed the proposed design and **APPROVED** development and deployment of the OTC ISIN and UPI templates.

8 Multiple Commodity Index Support

The DSB presented an issue concerning support for multiple Commodity Indices within the Commodity Multi-Exotic templates that may result in a discrepancy of CFI codes within the DSB hierarchy.

In order to resolve this issue, the DSB proposed the following changes:

Support Multiple Commodity Indices in Multi-Exotic and Non-Standard templates.

- Update Multi-Exotic and Non-Standard Commodity templates to allow the entry of multiple Commodity Indices.
- Allow entry of identical Commodity Indices eg: "OTHER", "OTHER".

Prevent Single Proprietary or Commodity Index in Multi-Exotic templates.

• Change Multi-Exotic templates to reject OTC ISIN request based on a single underlying Commodity Index

Members of the PC reviewed the proposed design and **APPROVED** the change.
