- Equity Total Return Swap The DSB **APPROVED** the best practice guidance.
- Rates: Forward: Debt The DSB accepted the need for a best practice, but amended the
 proposed text practice to cover any debt instrument. The DSB will consider the need for
 supporting best practice to be provided on the FRA_Other template.
- Credit: Forward: Debt The DSB rejected the need for best practice and questioned the need for a template itself. The DSB will reach out to the CDIDE for additional information to support its inclusion. The DSB will position implementation of the template until the PC are satisfied.
- Non-Standard Products The DSB rejected the proposed best practice and requested more clarity surrounding the scenarios the best practice intended to clarify. The DSB are to reach out to the CFTC who will provide examples of scenarios.

10 New or Changed Product – Governance

The DSB needs to establish a governance approach to better allow request for new or changed products be reviewed and approved by the PC before development can be started. In order to allow the PC to make
