7 CDS Single Name Underlier: Proposed Best Practice

The DSB presented a draft version of the proposed best practice text , see below, for review and approval by the PC.

- If the CDS is based on the credit risk of a Legal Entity use the LEI to identify the underlier. If the Legal Entity has not been assigned an LEI, then a value of "OTHER" should be entered in the LEI attribute.
- If the CDS is based on the credit risk of a single Fixed Income Security the user should use the ISIN to identify the underlier. If the Security has not been assigned an ISIN, then a value of "OTHER" should be entered in the LEI attribute (since a value of "OTHER" is not valid as a Security identifier.

As the meeting was not quorate, the DSB will share the text with PC members via email and, pending feedback, will be approved at the next meeting **>Action603**

8 Underlying Index ID SC

After previously approving the formation of the Underlying Index ID Sub-Committee the PC were represented the scope and format as well as being reminded to submit their nominations for membership of the proposed committee.

9 DSB-3387 : Underlier Name – ASB Data Review

Per the request of the PC, the DSB have performed analysis of the underlier name data used to populate the issue description in ISIN/UPI creation by the DSB with the data being provided by the ASB. ASB

The analysis highlighted data quality issues with the Issue Description attribute sourced from the ASB, and whilst having full coverage, the 'free text' nature does not always provide an accurate description of the underlier name. The alternative approach would be to use the available FISN, defined by ISO 18774, but is not available in all cases.

The DSB discussed both approaches, and acknowledged in the short/medium term and in the absence of a alternate source, the ASB data should continue to be used as a single source of Underlier Name.

The DSB are to summarize the discussion and share analysis via email with PC members, with a view to discuss further at the next meeting. *>Action604*

10 CFI Migration – Mapping to new rates values

As part of the CFI migration work, a number of differences/changes/updates between CFI 2015, 2019 & 2021 have been highlighted. These changes and the impact of them on the existing rates attributes and templates, were presented to PC members. A summary of these changes can be found below
