The DSB informed the PC of the upcoming ISDA updates to the commodity reference prices, Initially this will be focused on Agriculture products, with a targeted August release, but will then move onto Energy

and then other products.

The DSB has held talks with ISDA to discuss a coordinated release with their official release so that the industry start using the new values as soon as they are made available. The DSB's approach to this will likely mirror the 2021 FRO release, but final approach will be driven when ISDA documentation is finalized.

9 **CDIDE Product Review**

The DSB presented the actions agreed at the previous PC meeting following the PC review of the "proposed" best practice guidance for Forward Debt products.

10 **New or Changed Product – Governance**
