#### 1 INTRODUCTION

This document is designed to act as a manual for users to interpret the Product Definitions in the DSB UPI Service.

This document provides the user with the detailed description of the UPI Product Definition content such as attribute enumerations, validation, normalization, and derivation where applicable.

#### 3.2.1 Notional Currency and Other Notional Currency

- Currency for both legs cannot be identical.
- If the following attributes have the same currency, an error message will apply "Error: Notional Currency and Other Notional Currency cannot be identical".
- If the Notional and Other Notional Currency are both CNY and has no Place of Settlement attribute, an error message will apply "Error: Notional Currency and Other Notional Currency cannot be identical".
- If the Notional and Other Notional Currency are both CNY and has Place of Settlement of "Hong Kong", the combination string is acceptable.
- If the Notional and Other Notional Currency is both CNY and Place of Settlement is not "Hong Kong, an error message will apply "Error: Place of Settlement must be Hong Kong for CNY/CNY request".

## 5 SUPPLEMENTARY INFORMATION

## 5.1 Best Practice Guidelines

- Users submitting a value for Settlement Currency in any FX UPI product template are advised that the attribute is optional and should not contain XXX without prior authorization of the DSB Product Committee.
- Users are requested not to submit a value of XXX which is defined in the ISO 4217 standard as "no currency involved in the transaction" and thus is not seen as appropriate for use in FX instruments.
- The Product Committee requests that users wishing to submit XXX as an input value should provide a business case to secretariat@anna-dsb.com with supporting information.

## 5.2 Additional Comments

- The Settlement Currency for the UPI will follow the behaviour / definition of the equivalent OTC ISIN templates including the attribute where the OTC ISIN has one and excluding it where OTC ISIN excludes it.
- The attribute Place of Settlement is applicable to NDS and Non-Standard products.
- Short Name abbreviation for Option Type across Asset Classes: Equity uses [CALL; PUTO; OPTL]; Commodities uses [Call; Put; OPTL]; Rates uses [Call; P; Opt]; Foreign Exchange uses [Call; Put; O] where it is applicable. For Credit, option type is not part of the short name.
